Out of Bounds - Defined by White Stakes or Fence No. 5, 6, 7, 10, 11 and 15.

LOCAL RULES

- Everyone must register in Pro Shop.
- No more than a foursome.

- Replace divots and repair ball marks.
- Smooth traps.

GOLF CAR RULES

- No more than two persons on a golf car.
- 90 Degree Rule MUST be observed on holes with continuous cart paths.
- Cars must stay on paths on Par 3 holes.
